Running Instances of the Server Software.

For each server to which you have assigned the required number of software licenses, you may run on the licensed server, at any one time:

/ One instance of the server software in the physical OSE, and / Any number of instances of the server software in virtual OSEs (only one instance per virtual OSE).

Incorrect:

The alternatives do not allow 10 virtual machines on each server:

Not A: For each server with Windows Server 2012 R2 Standard only two instance of the server software in one virtual operating system environment. Not C: For each server with Windows Server 2012 R2 Essentials only one instance of the

server software in one virtual operating system environment.
