Software inventory is collected when the Enable software inventory on clients setting is enabled in client settings. After software inventory is enabled and the clients run a software inventory cycle, the client sends the inventory information to a management point in the client\\'s site. The management point then forwards the inventory information to the Configuration Manager site server, which stores the inventory information in the site database. Software inventory runs on clients according to the schedule that you specify in client settings.
