(Level 2: Offset 306, len 8, comp 5 of 11, #1, DI 00000025:) Data at offset 306 ('19970428') was found to be of TYPE X'0009' (OrderDate Field Data).

(Level 2: Offset 315, len 0, comp 6 of 11, #1, DI 00000026:) COMPONENT number 6 of TYPE X'0003' (LegacyRecord Data) is required, but does not exist.

(Level 1: Offset 264, len 0, comp 1 of 1, #4, DI 00000021:) COMPONENT number 1 of TYPE X'0002' (File Data): occurrence 4 is optional and does not exist.

(Level 0: Offset 0, len 264, comp 1 of 0, #1, DI 00000021:) Data at offset 0 ('XRF-1A-150:ABCWI') was found to be of TYPE X'0002' (INPUT 1 was valid but contained 940 bytes of unknown data at the end.
