QUESTION 1

A state model is a graphical representation of the states, transitions, and actions of an entity or an object within a system or solution. Option B is incorrect because a business capability analysis is not a requirement viewpoint that will help the BA provide information on how requirements are structured, but a requirement viewpoint that will help the BA provide information on what an organization needs or wants to achieve its goals or outcomes. A business capability analysis is a technique that identifies and evaluates the capabilities or skills that enable an organization to perform its functions or processes. Option D is incorrect because data streams are not a requirement viewpoint that will help the BA provide information on how requirements are structured, but a requirement viewpoint that will help the BA provide information on how data flows and transforms within a system or solution. Data streams are sequences or patterns of data that are produced or consumed by a system or solution.

QUESTION 2

A business analyst (BA) collected scanned notes, documents, and photos of whiteboards showing the results of a workshop pertaining to an accounting system replacement. What is the BA\\'s next course of action?

- A. Meet with stakeholders to review the information sent
- B. Meet with a corporate accounting user
- C. Manage stakeholder collaboration
- D. Develop a business analysis information package

Correct Answer: D

A business analysis information package is a collection of information that summarizes the results of business analysis activities. It helps to organize and present the scanned notes, documents, and photos of whiteboards in a coherent and consistent manner. QUESTION 3

An organization has two different solutions to grow its business. One project is worth \$375,000 to the organization. The second project is worth \$565,000 to the business. The organization can only do one of the projects and elects to do the second project for \$565,000. What is the opportunity cost of this decision?

A. \$190,000

B. \$565,000

C. \$375,000

D. \$940,000

Correct Answer: C

The opportunity cost is the whole amount of the opportunity that can be seized. In this instance, the opportunity cost is \$375,000, as this is the project that the organization can\\'t do. B is incorrect. This answer is the value of the project the

organization has elected to do. A is incorrect. \$190,000 is the difference between the two projects and does not reflect the opportunity cost.

D is incorrect. This is the value of both projects combined and does not represent the opportunity cost.

QUESTION 4

The Chief Executive Officer (CEO) is concerned about how two client bases are going to be integrated and serviced in the newly formed company after a merger. A project has been initiated to implement a Customer Relationship Management (CRM) system for the new company that will contain the client information from both companies. What must the business analyst (BA) do to address the concerns of the CEO?

A. Demonstrate the functionality of the new CRM

B. Reuse requirements models from each company

C. Ensure all regulatory requirements are documented

D. Create merged viewpoints of the requirements

Correct Answer: D

The BA must create merged viewpoints of the requirements to address the concerns of the CEO. This is because a merged viewpoint is a way of combining the perspectives of different stakeholders into a coherent and consistent set of

requirements. A merged viewpoint can help to resolve conflicts, identify gaps, and ensure alignment among the stakeholders. Creating merged viewpoints can also help to integrate and service the two client bases in the newly formed

company after a merger. The other options are not sufficient or relevant to address the CEO\\'s concerns.

QUESTION 5
