The policy is stored in the EAR file.

You can register EAR files only by using an XML script with predeployed mode. You can remove EAR files by using either the administration portlet or an XML script.

The context root is assigned by the EAR developer and stored in the file application.xml. You must ensure that the context root that you specify when you register the portlet matches the one specified in the EAR application.xml. (refer to the

sample XML file RegisterPreDeployedEAR.xml.

The portlet application is already extracted and deployed into the application server as part of the EAR file.

The portal server reads the available portal configuration information (portlet.xml, etc.) from the location where the contained WAR file was extracted to.
