Step 1: Add your account as a site collection administrator of the Onedrive site.

Each OneDrive for Business account has a OneDrive for Business Site Collection that stores files for that account. By default, only the user that owns the OneDrive for Business account is set as a Site Collection Administrator for their

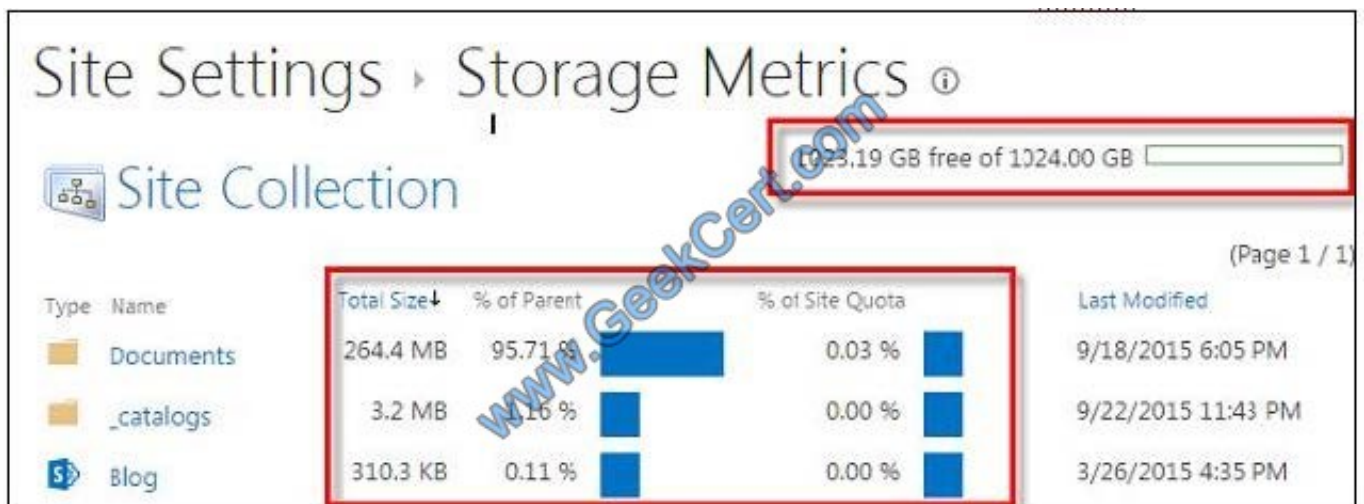
account. Additional Site Collection Administrators have to be added explicitly by a Office 365 global administrator or the owner of the OneDrive for Business account.

Step 2-3:

How to check file storage usage in OneDrive

Follow the steps below to check how much space you have used and how much of the quota remains available.

1. From within OneDrive, click the Settings (gear) icon in the upper right corner and select Site Settings.
2. Under the section Site Collection Administration, click Storage Metrics.
3. This window shows you all the files, folders and other types of content within your OneDrive space and how much space they use. At the top you can see how much free space is available.



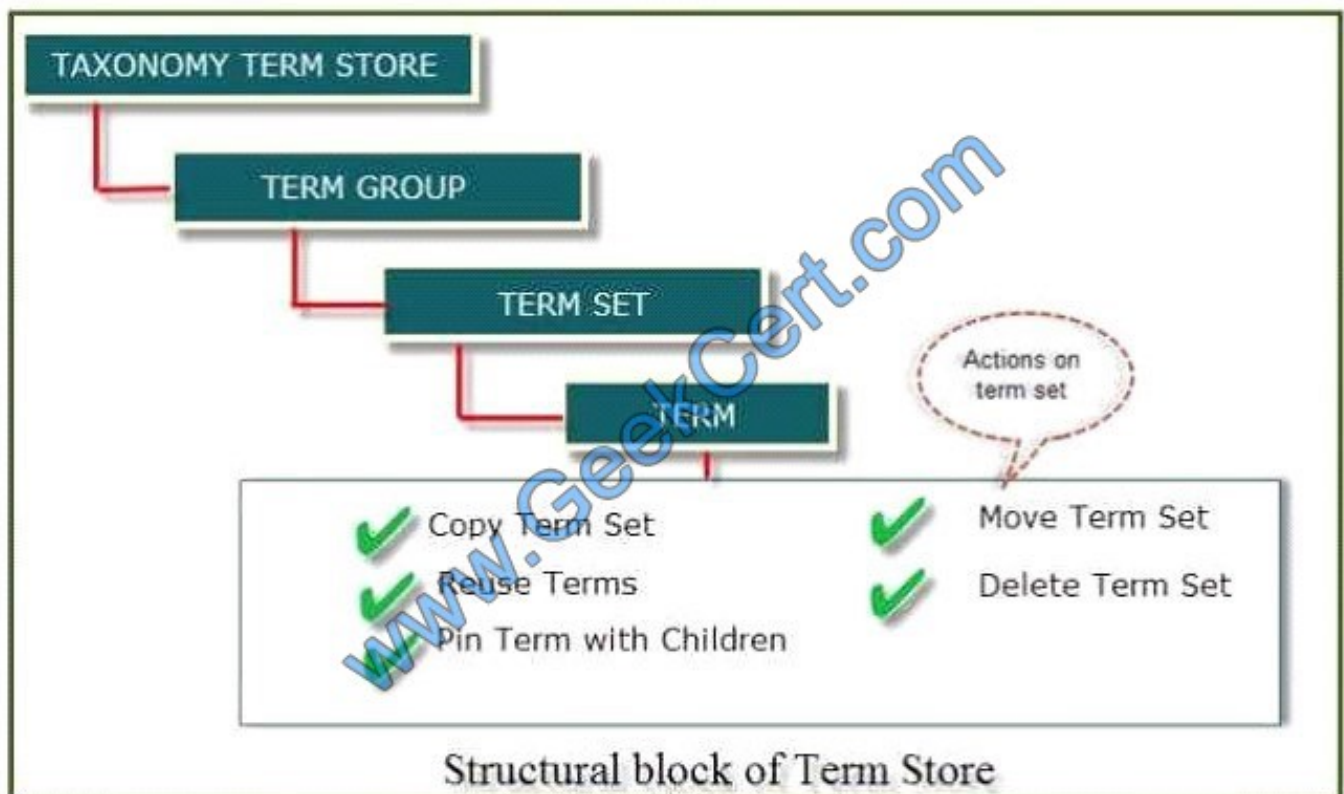
