### QUESTION 1

A developer uses Invoke Process activity to execute a child process. How can the developer differentiate logs of the child process from logs of the parent process?

Correct Answer: D

Logs generated by the child processes only contain the outcome of the execution and errors, and are written in the same place as the ones from the parent and can be differentiated by the ProcessName field in local logs and Process column in Orchestrator.

### QUESTION 2

A developer uses REFramework to create complex process automation. In the InitAllSettings state, the robot retrieves all required assets from the Orchestrator. All values are stored in a Config dictionary which is passed between workflows. What happens if, during the processing of a queue item, the value of one of the assets was changed in Orchestrator?

- A. The value of the asset will be null.
- B. Robot will throw an error when trying to use the value of that asset.
- C. Robot will use the new value of the asset.
- D. Robot will use the old value of the asset.

Correct Answer: D

If the Config file is used to store values from the Orchestrator at the beginning of the process, any changes in assets will not affect the robot, as all values were retrieved prior to the change. However, if robot uses the Get Asset activity each time before using the asset, then robot will use the latest value of the asset.

### QUESTION 3

A project contains a Try Catch activity in the Main.xaml workflow. In the Catch section, there is a Rethrow activity. The process is started from Orchestrator and an exception is caught in the Try section. What is the expected result?

Correct Answer: D
